**Question 1.** Explain how the shipping industry contributes to the growth and sustainability of international trade? **(2 Marks)**

**Question 2.** Discuss the various factors that influence a shipper's choice of transport mode in international trade. Provide at least 3 examples along with brief analysis on how they impact the decision making process for shippers. **(3 Marks)**

**Question 3.** Read the following Shipment Scenario and answer the following questions. **(8 Marks)**

Al Khayat Ltd, a company based in Sanaa, has a contract to export 8X40' GP container of garments to their client, Al Marzouqi LLC, located in Sohar, Oman. Al Khayat Ltd needs a reliable logistics partner to handle the complex international transportation and customs procedures, and they select Kuehne + Nagel. Kuehne + Nagel arranges for the shipment to be transported via a container vessel called the MSC Silver II from the Port of Aden and voyaging through, Port of Mukalla, Port of Salalah, Port of Duqm to Sohar's Sohar Port. This vessel is owned by Medbulk Shipping & Trading. and has local shipping agents in both Aden and Sohar.

Upon arrival in Port of Sohar, the cargo is unloaded by C. Steinweg Stevedoring, who then transfers it to a designated storage area. The shipment was initially loaded in Yemen by Asal Al-Arab Shipping Co. The MSC Silver II subsequently continues its liner service route to Khor Fakkan and Jebel Ali Ports.

Al Khayat Ltd sends all the necessary documentation to Al Marzouqi LLC, who opts to engage TruKKer to facilitate customs clearance and transport the goods to their distribution center in Sohar.

2. Who is the stevedore at Port of Discharge?
3. Who is the forwarder at the place of Export?
4. What is the Port of Loading?
5. Who is the shipping line?
6. What is the vessel type?
7. What is the cargo?
